

## **Traveler Information Terms and Conditions of Use and Access and Development (“Terms”) for the New Hampshire Department of Transportation (“NHDOT”)**

In order to use this Traveler Information website you must agree to the Terms. You can accept the Terms by:

- (b) using the information within the site. In this case, you understand and agree New Hampshire Department of Transportation (“NHDOT”) will treat your use of the site as acceptance of the Terms from that point onwards.
